1. Welcome and apologies for absence

	 The proposed new bungalow was very close to the 		
	original bungalow, in what could be called a		
	cramped position. It was also a backland		
	development. This was out of keeping with the		
	street scene which was an area of large individual houses with good sized gardens running along the		
	main road through the village. The original		
	bungalow was only granted planning permission in		
	the 1960's or 1970's, because it was needed to		
	house staff from the Cheshire Home.		
	 If planning permission was granted it would spoil 		
	the view from The Old Gt. Bromley Hall (now		
	Cheshire Home) to the historic church.

 Cllr Mander advised that tree works following the tree survey had been completed apart from the oak tree removal in Church Meadow, and the PICUS survey remained outstanding. It was agreed that a bat survey would be carried out before the removal of the oak tree. The Closed Churchyard gate repair was outstanding and it was further agreed to remove the now defunct light bollard. The steps along Footpath 17 at Bouge Hill were still

in need of repair, and the Footpath 5 issue at Lilley's Lane would be monitored to ensure access. The Clerk undertook to chase the outstanding repairs.

- Cllr Smith reported that two Speedwatch sessions had taken place and the sign above the recycling site had been installed.
- Cllr Nicholls reported that TDC's Planning committee had deferred the planning application for Pallett Plus for six months. The Remembrance Service had been well attended, with another excellent performance from Oliver on the bugle.

d) Hare Green Sub-Committee's Report Cllr Lord reported that the 29 responses to the residents' survey would be collated and a report prepared for the next meeting.
