Cllr Guglielmi advised that the Essex Highways Liaison Officer (HLO) for the Tendring area had met a local resident and discussed the Local Highways Panel Scheme for Harwich Road and advised the scheme would hopefully be delivered in the first quarter of 2023/24. The white line refresh for the junction at the Courthouse had been requested. The HLO had also spoken with a resident about the Rally.

Cllr Nicholls advised that Hall Road was to be closed while the barrier was being repaired.

**Clir Hardy** reported he had met with Proludic to discuss the planned works at the Hare Green play area. Work was expected to start in January 2023 and take two weeks to complete. A payment schedule had been requested.

**CIIr Blowers** had arranged replacement of pads in both defibrillators. A Bleed Kit had been purchased and installed at The Cross, with an invoice submitted for reimbursement to CIIr Blowers for the sum of £516.98.

**Clir Nicholls** provided an update on the requested additional disabled parking spaces at Church Meadow. He had spoken with the Head Teacher of St George's School who would be exploring an alternative option. Festive teas would be delivered to 70 residents on Monday 19<sup>th</sup> December from 11.30am. A press release was to be published. Local
