10. Highways update

Cllr Nicholls had attended a meeting with the Portfolio Holder for Highways and been successful in obtaining a reduction to 30mph along Harwich Road.

The Clerk undertook to provide an update on the 20's plenty schemes.

Members discussed the recent removal of cats eyes along some local roads. It was thought that potential road surfacing may be the reason.

11. Retail shop at Little Paddocks

Members considered and agreed to support an application for a Post Officer counter.

12. Proposed litter bin on Parsons Hill

Members considered the costs associated with the purchase, installation (approx. £410) and emptying (approx. £75 per annum) of a 110l bin, which would be emptied twice a week by Veolia. It was agreed to go ahead with the purchase.

13. Replacement flower tubs

Members considered the cost for replacement wooden flower tubs which had been sourced locally for £25 per tub. Eleven tubs were required and this was agreed. It was further agreed to move the flower tub at Selectacars further along the road to a more enhanced position.
